GRANT OF SHARE OPTIONS

This announcement is made pursuant to Rule 17.06A of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

The board (the “**Board**”) of directors (the “**Directors**”) of Pantronics Holdings Limited (the “**Company**”) hereby announces that on 16 October 2019, the Company offered to grant share options (the “**Options**”) to selected grantees (the “**Grantees**”), which subject to the acceptance of the Grantees, carry the rights to subscribe for a total of 3,650,000 ordinary shares of HK\$0.001 each of the Company (the “**Shares**”, each a “**Share**”), pursuant to the share option scheme adopted by the Company on 27 October 2016.

Details of the Options offered to be granted are as follows:

Date of grant : 16 October 2019 (the “**Date of Grant**”)

Exercise price of the Options offered to be granted : HK\$4.36 per Share, representing the highest of:

- (i) The closing price of HK\$4.18 per Share as stated in the daily quotations sheet of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) on the Date of Grant;

(ii) the average closing price of HK\$4.36 per Share as stated in the daily quotations sheet of the Stock Exchange for the five business days immediately preceding the Date of Grant; and

(iii) the nominal value of HK\$0.001 per Share.

Number of Options offered to be granted : 3,650,000 Options (each entitling the holder thereof to subscribe for one (1) new Share)

Closing price of the Shares on the Date of Grant : HK\$4.18

Vesting and Validity period of the Share Options : Within ten (10) years from the Date of Grant (both dates inclusive), in accordance with the following schedule:

(i) one-third of the Options are exercisable on the 1st anniversary of the Date of Grant;

(ii) one-third of the Options are exercisable on the 2nd anniversary of the Date of Grant; and

(iii) one-third of the Options are exercisable on the 3rd anniversary of the Date of Grant.

None of the Grantees is a director, chief executive or substantial shareholder (as defined under the Listing Rules) of the Company, or an associate (as defined under the Listing Rules) of any of them.
